

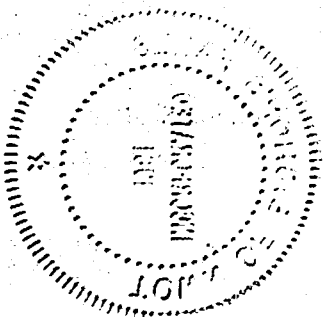



BACKGROUND

Amendment No. 2 to the Bishop's Falls Development Regulations is enacted to comply with Amendment No. 2 to the Bishop's Falls Municipal Plan.

The area of the proposed amendment is approximately 37,000 square metres (3.7 hectares).

PUBLIC CONSULTATION

Notice of proposed Amendment No. 2 was provided in the following ways:

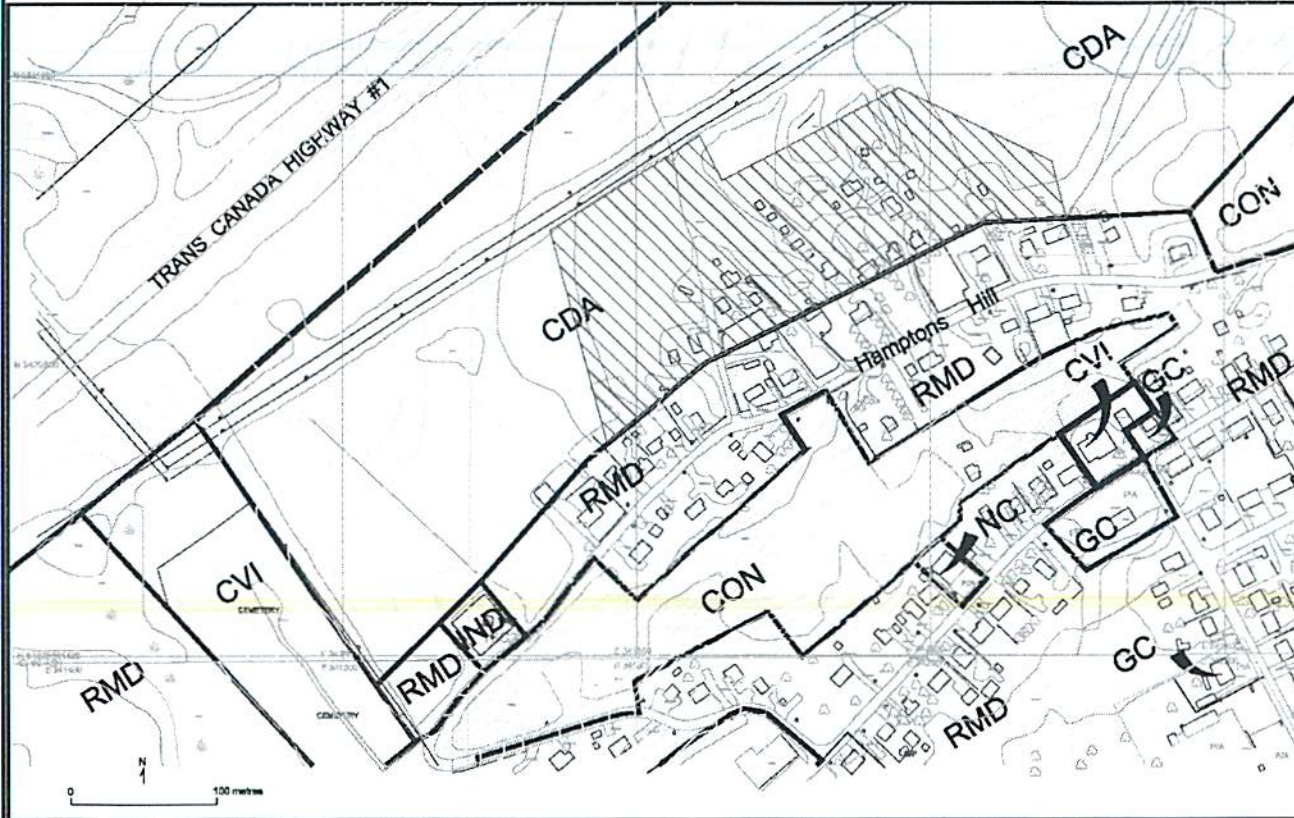
- (1) Advertisement in the June 15 edition of the Advertiser newspaper.

A period up to June 26 was provided for the submission of comments. No comments were received as of the deadline.
