Minutes

Item 1: Call to Order

Mayor R. Hobbs called the meeting to order at 4:40 pm on April 27, 2010 and presided with the following individuals in attendance:

It was agreed, by consensus, that Standing Order 3.1 pertaining to notice would be suspended to allow special public meeting 1266 to continue.

Item 3: Arena Boards Replacement Project

The Town Clerk explained that since March 30, 2010 there have been several significant developments pertaining to the replacement of the arena boards. Soon after sending the letter to ACOA on March 31, 2010 the Town received a verbal response. Given the nature of the RINC program (federal stimulus), all the funding was committed several months ago; therefore, there is no slack under RINC that can be allocated to this project. Furthermore, the Town was attempting to avoid the involvement of the engineers outside of the design process. After speaking to officials with the Town of Springdale, it was decided that tendering and contract administration could be managed internally. This is no longer an option because of Municipal Affairs guidelines; therefore, Council will need to approve the Client-Engineer Contract with Design Management Group (DMG).

Last week DMG prepared a cost estimate for the entire project. The design is now based on a bi-fold gate rather than electronic. According to the engineers, the project will cost approximately \$174,960 (PST included) and the engineering fees are \$11,448 (PST included). This equates to a \$37,282 contribution from the Town, \$31,906 from ACOA, and the balance is being sought from the Municipal Affairs (the current approval is for \$44,670).
