Item 3: Arena Boards Replacement Project

Mayor Hobbs updated Council on the developments concerning the replacement of the arena boards. ACOA will not entertain an extension past March 31, 2011; therefore, installation in April is not an option. After speaking to the engineers, it was discovered that one (1) of the contractors can supply and install the boards before December 1, 2010; however, this depends on the contract being awarded by October 15, 2010. The stadium opening would, if this option is chosen, be deferred until that time. Alternatively, Council could wait until 2011 for installation, but the stadium would need to be closed early February. The Councillors agreed that delaying the opening until December 1, 2010 was the more practical option – it will result Public Council Meeting No. 1277

in fewer interruptions for the user groups. The user groups will need to be informed of this development, and a face-to-face meeting will be more appropriate than a letter.
