#### DISCUSSION/DEBATE

Councillor King enquired why the Town's Animal Control Regulations, could not be enforced for the removal of a horse located within a residential area. The Mayor also stated that a review was

conducted by our legal counsel and his findings recommended that an amendment to the Animal Control Regulations 2010, to include the authority of the Town of Bishop's Falls, to issue orders.

It was noted by the Mayor that this Regulation does not meet enforcement standards, but, a fine structure is an option.

### Summary of options:

- (1) Amend then *Animal Control Regulations* to include the order process. This will empower Council to issue an order and, if the owner does not comply, undertake to have the animal removed. The matter can also be taken to Court.
- (2) Under Section 11 of the *Animal Control Regulations*, petition the Court to impose a fine because the owner has breached Section 5 of the same regulations.

Councillor Mills and Councillor Budgell enquired on the request to obtain items from the Centennial Celebration Committee on behalf of the Heritage Society/Museum for their annual operation. The Town Clerk will review the request and contact the Heritage Society/Museum. Report will go to back to the February 1, 2012, Community Relations Committee.

Councillor Canning that there will be a Broomball Meet in Bishop's Falls in the coming months, and asked if there were any items left from the Centennial Celebrations for donation. It was noted that there are pins and other various items. The Town Clerk will take stock of inventory. Request to brought to the Community Relations Committee on February 1, 2012.

The consultant was selected on the basis of qualifications and experience, and demonstrated a clear understanding of the project; along with the proposed methodology and ability to complete the work in a timely manner.

The Mayor updated Councillors on the status of the Standing Operating Procedures, by stating that the SOP is being reviewed and updated and should be going forward to the next Public Meeting for Council's approval. In the interim, His Worship did state that during consultation with the Fire Protections Officer, Fire and Emergency Services, Department of Municipal Affairs, that Council can recommend the Fire Chief be given Discretionary Power to make decisions regarding emergency services outside of the boundaries of the Bishop's Falls, until the SOP has been approved.

It was noted by the Mayor that the public has been previously advised, and that any further notifications should be forthcoming by Central Waste Management. The Mayor will direct Administration to contact Central Waste Management in regards to public notices.

The Mayor and the Town Clerk will be attending Regional Meeting for the Central Newfoundland Waste Management on January 26, 2012, which will include the following municipalities: Bishop's Falls, Botwood, and the Lewisporte area. And will report back to the Standing Committee.
