8.5 HERITAGE CENTRE

Councillor Budgell stated that he has been approached by residents due to the poor condition of the Heritage Centre due to vandalism. The tone of residents is that there is a lack of concern by Council to renovate. The Centre is due to open soon, and residents would like to see some renovations done prior to the tourist season.

It was discussed that at in the last few years that idea of closing the current site to develop a new Heritage Centre by Fallsview Park but this needs to be dealt with for the present until the Town knows

where the site will be. The Town will look into tendering work or getting the Public Works Dept. to do the work. Proceeds from the current site could finance a site development.

Emphasis to be placed on beautification of the Streets, and the best way to get everyone together.

Councillor King, Councillor Canning and Councillor Hynes will form an ad-hoc Committee and will bring forward the outline at the next Committee meeting.

8.7 TRESTLE LIGHTS

Councillor Canning stated that the type of lights for the trestle has been identified, and the approximate cost for the project is \$35,000.00, based on engineering and electrical estimates. Councillor Canning noted that the Committee will be meeting soon to finalize the price quotes and will be presenting those figures to the Town Treasurer.

The Trestle is considered to be a big tourist attraction, and lighting would enhance the appeal for tourists and locals alike.

Councillor Budgell advised that the Heritage Committee is GST registered and this project could very well be done through this process.
