Item 1: Call to Order

Mayor R. Hobbs called the meeting to order at 5:00 pm on August 2, 2012 and presided with the following individuals in attendance:

Item 2: Adoption of the Agenda

Item 3: Town Clerk/Land Officer Selection Committee Report

Mayor Hobbs, on behalf of the Selection Committee, presented the following report:

- A total of 33 applications were received; five (5) candidates were selected for an interview.
- The interview was structured and included two (2) practical (written) exercises.
- Out of the five (5) candidates selected, three (3) were felt to possess relevant qualities and qualifications; however, the Committee felt that one (1) individual, Mr. Dan Oldford, presented the best attributes (i.e. commitment, knowledge of government processes, writing skills, research and analytical abilities, etc.).

- Based on the interview results, the Committee recommended that Mr. Dan Oldford be appointed to the position of Town Clerk/Land Officer.

DEBATE

The following points were raised during debate: (1) Some Councillors felt that Mr. Oldford was a good choice for the position, although there are certain concerns. For instance, Mr. Oldford is accustomed to leadership positions and the Clerk – while serving an important role in the Town – takes direction from Council. He/she serves as secretary and in many ways represents the pen of Council. Some felt Mr. Oldford may not be comfortable in this context; (2) The Town needs stability in the Clerk position. It was believed Mr. Oldford will be committed for the long-term, and this is a strong consideration; (3) Council need not, if there are concerns, rush the decision process. It can take additional time and consider other applicants; and (4) Council has great respect for Mr. Oldford. The concerns raised are professional in nature and not personal.

The Town Clerk/Manager advised that, in accordance s. 59 (1) of the *Municipalities Act, 1999*, the appointment of a Clerk requires a 2/3 vote of the Councillors in office.

The Selection Committee was instructed to review the matter and prepare a further report for the public meeting on August 21, 2012.
