Item 4: Hobbs Park Project

Motion 222/2012 – Councillor Budgell/Councillor Hynes

Whereas the contractor for the Hobbs Park Road Improvement Project, has notified Council via email that if the project were to begin October 22nd, 2012 paving would take place in the middle of November; and whereas the average daily maximum temperature in November is 4.9 degrees; and whereas municipal specifications state asphalt shall not be placed until the ambient temperature is 7 degrees; and whereas if Council were to force the Contractor to go ahead this year, the contractor will submit a letter requesting Council's approval to void the warranty; and whereas the town will be assuming much risk if the warranty is voided; therefore, be it resolved that council shall, on recommendation of the Town's engineers, defer the Hobbs Road Improvement Project until the spring of 2013 provided (a) the contractor agrees the project shall be placed at the top of its list and (b) the cost of the project shall not exceed what has been tendered; be it further resolved that Council shall immediately advise the residents of Hobbs Park about the delay; be it further resolved that Council shall arrange a public meeting for the residents of Hobbs Park to explain the reasoning behind the delay in project.
