Item 2: Adoption of the Agenda

Item 3: Carbon Credit Contract

Resolution 97/2013 - Councillor Canning/Councillor Hynes

Whereas Council has received a proposal from a company to take control of Carbon Credits resulting from the Sewage treatment Project; and whereas the sale of such Carbon Credits is beyond Councils ability internally; and whereas this contract would have no cost to Town, and in fact could realize

revenue for the Town; and, whereas the contract does not have a termination clause; be it therefore resolved that Council approve the contract in principle, and, be it also resolved, that such a contract shall have a maximum of 15 year term included, and, be it also further resolved, that a request shall be a made to meet with the company to discuss such approval.

DISCUSSION/DEBATE

The following points were raised during discussion: (1)The contract which was submitted did not contain an out option, (2) Council would like to have a time frame on whole contract, (3) Realistically can we possibly expect to sell the credits without an outside agent. Some clarification on the wording should also be done prior to signing.

Item 4: Fallsview Park Reservation System Policy Changes

Resolution 98/2013 - Councillor Canning/Councillor King

Be it resolved that Council shall adopt the following amendments to the Fallsview Municipal Park Policy Manual 2012 effective immediately:

- (1) S. 8.0 (a), which currently reads, "Reservations can be made as of the second Monday of May up to the Park's scheduled closing for the year", is amended to read, "Reservations can be made as of the second Monday of May up to and including the day before the Park's scheduled opening. The Park shall not accept reservations during its operational period."
- (2) S. 8.0 (d), which currently reads, "Notwithstanding s. 8 (c), a camper may cancel a reservation no later than one (1) week prior to the Park's scheduled opening. In such cases, the camper shall be entitled to a 90% refund. A 10% cancellation fee shall apply", is amended to read, "A camper may cancel a reservation at any point during the operational period; however, the following cancellation fees shall apply: (1) Where a cancellation is made more than five (5) days in advance of the camper's scheduled arrival, a 10% cancellation fee shall apply. (2) Where a cancellation is made five (5) days or less in advance of the camper's scheduled arrival, a 50% cancellation fee shall apply".
- (3) An additional subsection, numbered 8.0 (e), shall be inserted to read as follows: "A camper may reserve only two (2) sites at any given time".
- (4) "There shall be no refunds under any circumstances" shall be deleted from s. 8.0 (c).

Item 5: Gas Tax Project (Main St)

Resolution 99/2013 - Councillor Budgell/Councillor King

Whereas Council plans to resurface Main St., from the west end of the 2012 Main St. Project, to the West intersection of Bishop's Falls; and whereas the previous estimate from DMG was for 300 metres of paving; and whereas once measurements were completed it was revealed that to complete the project to the west end, would require an additional 90 metres of paving, be it resolved, that Council shall approve the extension of the 2013 Main St. West project by 90 metres.
