### 9.1 Application for Crown Lands 13 Mile Crossing

could require additional parking, be it resolved, that Council shall approve the redevelopment of 2 residential Dwellings on Aspen St. by NL Housing to a Community Centre, conditional on NL Housing address the parking issue, be it further resolved, that the Town Clerk shall advise TRACT Consulting of Council's desire to have the specified area rezoned to CSS.

### 12.1 Proposed Resolution to MNL

### Resolution 210/2013 - Councillor Budgell/Councillor Canning

Whereas Council has consistently felt that the current Municipal Collection of Taxes is unfair and regressive; and whereas it can be clearly shown the current tax regime does not take into account a number of issues facing the today's population; and whereas Municipalities Newfoundland and has shown to be a viable platform to make representation to the Government of Newfoundland and Labrador on changes to policy, be it therefore resolved that Council shall submit a resolution to MNL for its fall convention:

## Proposed MNL Convention 2013 Resolution

WHEREAS the property tax regime in Newfoundland and Labrador is regressive in nature;

AND WHEREAS the regime adversely impacts seniors because their property values typically increase overtime along with taxation, but their incomes remain fixed for the most part;

AND WHEREAS municipalities, while implementing policies to mitigate the increasing burden of property tax on seniors, cannot resolve the inherent regressive nature of the property tax regime;

AND WHEREAS the property tax regime, by definition, exempts individuals who do not own property from paying property taxes, yet many of these individuals are living in or around municipalities and are utilizing their services;

AND WHEREAS the poll tax regime, which may apply when the individual is living in the municipal boundaries, is difficult to administer and does not serve as an effective taxation policy;

AND WHEREAS municipalities are paying a large amount to operate the Municipal Assessment Agency, which is a necessary element of the property tax regime;

AND WHEREAS municipalities expend considerable human resources to collect property taxes;

AND WHEREAS these resources, financial and human, could be better utilized elsewhere;

AND WHEREAS a municipal income tax system, premised on the individual's ability to pay, applicable to all residents of Newfoundland and Labrador regardless of residency, and disbursed to municipalities through an acceptable formula, has the potential to replace the regressive property tax regime;

THEREFORE, BE IT RESOLVED that MNL shall strongly lobby the Government of Newfoundland and Labrador to explore the feasibility of replacing the regressive property tax regime, and other municipal taxation policies, with a *municipal income tax* that is premised on the individual's ability to pay,

applicable to all residents of Newfoundland and Labrador regardless of residency, and disbursed to municipalities through an acceptable formula.

#### **DISCUSSION/DEBATE**

The following points were raised during debate: 1. Council felt this issue needed to be raised at the MNL level. 3. Council also recognized that any request to change provincial policy has a better chance of success if presented by all the Municipalities in the province.

### 12.6 Dominic St. – DFAA/MCW Funding

A preliminary estimate of the proposed Igor damage repair project has resulted in the potential of a \$51,500 requirement from Council as its share. This would allow the completion of the repairs to the damage done by Igor in a way to prevent further flooding in the Dominic St. Area. Council has some concerns with these figures and the Town Manager will go back to DMG to assess some possible reduction in this proposal without increasing any flood risk.

### 12.7 Town Hall Renovations

### Resolution 214/2013 - Councillor Canning/Councillor Budgell

Whereas the Town Hall, and in particular the upper level, requires renovations and upgrades; and whereas the current design is not conducive to privacy, nor does it accommodate the needs of persons with disabilities; and whereas the Town engaged its engineers of record, Design Management Group, to prepare a revised floor plan for the upper level of the Town Hall and Chambers; and whereas the revised design will increase the number of offices and better utilize the space; and whereas the project will cost

approximately \$260,000 plus HST; therefore, be it resolved that Council shall seek special assistance funding from the Department of Municipal Affairs for 80% of the project costs (\$224,640 less GST); be it further resolved that Council shall commit the municipal share, totalling \$56,1560 (20%) from the treasury.

#### **DISCUSSION/DEBATE**

During Discussions the following points were raised: 1. The current structure is causing significant stress on administrative operations. The building, even with the current lift, installed does not meet accessibility requirements. 2. On numerous occasions residents have raised concerns about not being able to conduct a private conversation regarding Town issues.
