Item 4: Waste Water Treatment Project Budget Issue

Resolution 210/2014 - Councillor McDonald/Councillor King

Whereas the Town's consulting engineers and project managers, DMG Consulting Ltd., has projected a budget deficit of \$229,415 (including taxes) in relation to the wastewater treatment project (collector route and Abydoz system); and whereas Council believes it is in the best interest of the parties to



complete the wastewater treatment project as planned rather than to defer certain aspects to future fiscal years; therefore, be it resolved that the Town shall apply for \$229,415 in addition funding, less GST and shared on an 80 (provincial)/20 (municipal) basis, from the Department of Municipal and Intergovernmental Affairs,; be it further resolved that the Town shall apply to add the additional funding to the existing contribution agreement.

DISCUSSION/DEBATE

During discussion the following points were raised: 1. If council were to wait another year and apply for MCW funding for this deficit it would jeopardize planned MCW projects. 2. The original figures used for this funding arrangement were based on 2009 figures; therefore expectation of being able to stay within budget was somewhat unrealistic. 3. A request to consider cutting the scope of work to fit the budget was done at the start however any further cuts could affect the overall integrity of the project.
