Item 3: Gas Tax Capital Investment Plan 2014-2019

Resolution 218/2014 - Councillor King/Councillor Budgell

Whereas the *Ultimate Recipient Gas Tax Agreement* between the Town of Bishop's Falls and the Government of Newfoundland and Labrador was executed on September 11, 2014; and whereas the *Agreement* will provide the municipality with \$737,518 over the period between 2014 and 2019; and whereas the Town has \$86,805 remaining under the current gas tax agreement, bringing the total funds



available to \$824,323; and whereas Council generated and considered 16 projects for the gas tax funding; and whereas Council has identified four (4) projects that are most critical at this point and time; therefore, be it resolved that Council shall adopt the following gas tax Capital Investment Plan:
